

## Western NY Work Incentives Planning And Assistance Project (WIPA)

---

### What is the WIPA Project?

Our WIPA Project is funded by the Social Security Administration (SSA) and provides benefits advisement services to beneficiaries who are either working (full-time or part-time) or interested in going to work. Our benefits advisers, sometimes referred to as Certified Work Incentives Coordinators, are not employed by SSA. Their role is to assist beneficiaries in understanding SSA rules and navigating through the intricate SSA system. WIPA serves a 20-county area of Western and Central New York, providing free services through a number of partner agencies.

### Who is Eligible for WIPA Benefits Advisement Services?

A person must be working, about to start work, or looking for work and eligible for or receiving at least one of the following:

- ◆ Supplemental Security income (SSI) benefits
- ◆ Social Security Disability Insurance (SSDI) benefits
- ◆ 1619(b) Medicaid (for individuals who lose SSI due work and wages)
- ◆ Extended Medicare (for individuals who lose SSDI due to work and wages)

### What Can A Benefits Adviser Provide to a Beneficiary?

- ◆ Detailed information and advice regarding SSI, SSDI, Medicaid and Medicare
- ◆ Information about how work affects SSI, SSDI, Medicaid and Medicare
- ◆ Referrals to other supports available to persons with disabilities
- ◆ Written confirmation of information provided

### Our Benefits Advisers Can Help Beneficiaries:

- ◆ Obtain and/or retain Medicaid and Medicare health insurance while working
- ◆ Use work incentives, in some cases, to keep SSI or SSDI benefits as work activity increases
- ◆ Obtain funding for vocationally-related items such as tuition, a vehicle, or a computer
- ◆ Determine eligibility for other government benefits, such as special food stamp eligibility
- ◆ Avoid and/or reduce rental subsidy decreases while first working
- ◆ Avoid overpayment(s) of disability benefits
